Deputy Director, San Jose Downtown Association (SJDA), San Jose, CA, 2022-2024

Administered property-based improvement district (PBID) with \$5 million budget and five staff members. Managed the implementation of an unhoused outreach team, and clean and safe service expansion, for the PBID. Supported CEO transition efforts. Oversaw day-to-day human resources and finance functions for SJDA and its three affiliated organizations.

Director of Public Space Operations & Operations Manager, SJDA, 2016-2022

Managed successful PBID renewal, from consultant selection through planning and program design to property owner outreach, achieving an 89 percent ballot approval rating. Renewal of the property-based improvement district ensured a minimum of \$50 million investment in the public realm over 10 years for the district.

Led clean, safe, and beautification programming, vendors, and staff, inclusive of a \$3 million budget. Revamped private security program, including the recruitment of reserve police officers to work in an off-duty capacity. Worked collaboratively with the police and other agencies including those serving the unhoused population. Led staff efforts around behavioral health, public safety, and homelessness advocacy. Managed PBID annual reporting, collateral materials, and communications.

Membership and Outreach, SJDA, 2013-2016

Researched, selected, designed, and implemented a new membership database, combining membership information for both of SJDA's special assessment districts into one system for the first time, with full access for all staff. Managed Downtown Doors student art competition. Initiated and oversaw a comprehensive overhaul of business improvement district membership benefits. Managed membership functions, including welcoming new businesses, helping businesses with general downtown concerns, and connecting businesses with relevant services.

Development Coordinator, Family Supportive Housing, San Jose, CA, 2011-2013

Implemented comprehensive social media strategy along with production of agency newsletter and e-blast correspondence. Administered donor database and donor recognition efforts. Managed city, state, and federal grants, including creating applications, managing contracts, and reporting.
